There was presented and read by the City Attny A Bill for an Ordinance to levey the tax for the City of Hopkins for the year 1923.

On Motion it was ordered placed upon its first reading, This motion prevailed and it was read as follows, -

Be it ordained by the Board of Aldermen of the City of Hopkins as follows, -

There is hereby levied for the year 1923, a tax of Twenty-Cents on the One-Hundred Dollars valuation, on all taxable property, in the City of Hopkins, for general purposes, -and,

There is hereby levied for the year 1923, a tax of Thirty-Cents on the One-Hundred Dollars valuation, on all taxable property in the City of Hopkins, for the purpose of paying off the interest and bonds for the City Water-works, - and, -

There is hereby levied for the year 1923, a tax of Fifteen-Cents on the One- HUNDred Dollars valuation on all taxable property, in the City of Hopkins for the purpose of lighting the City of Hopkins.

This Ordinance shall be in force an effect from and after it passage and approval.

Passed and aproved this the 8th, day of May, 1923.

There was Also Presented, by the City, Attny, A Bill for an Ordinance leveying the Pol-Tax in the City of Hopkins for the Year, 1923,

On Motion it was ordered placed upon its first reading, This motion prevailed and it was read as follows,-

Be it ordained by the Board of Aldermen of the City of Hopkins Missouri, as follows.-

All mail persons between the ages of Twenty-One, and Fifty Years who have resided within the corporate limits of the City of Hopkins, Missouri. Thirty-Days, prior to the passage of this act, are hereby required to work on the Streets and Alleys of said City- Two-Days, for the year 1923, or in lieu thereof, to pay to the Street Commissioner, of said City the sum of TWO-DOLLARS,, and if said work is not done at the time and place at and for which notice is given by the street Commissioner, said Two-Dollars shall amediately become due and payable, and suit shall be brought for the collection thereof, according to law, and the City Atty, shall be allowed a fee of-Five-Dollars, Bor bringing said suit, which fee shall be taxed as costs against the defendent, in such suit against whom judgement is rendered.

This Ordinance shall be in force and effect, from and after its, passage and approveal.
