

--:--:-- ORDINANCE, NO.--(62)--:--:--

An,ORDINANCE, in relation to the "Water System, in the City of Hopkins, fixing the rates to be charged, and prescribing the manner of making connections to the Mains, and providing penalties for violation, thereof:-

Be it Ordained by the Board of Aldermen, of the City of Hopkins, as follows:-

Section,-1. All work in the Strees, and Alleys, in connection with water pipes shall be done by the employers, of said City, and all waters shall be furnished by said City, together with all fixtures, to the Street curb, along the Mains in said City, and the charges therefor shall be as follows:-

Tapping Water Main,	\$ 1.50
Goose Neck,	1.50
Stop,	1.50
Box,	1.50
Pipe end-fittings,	3.40
Digging,	3.10
Meter,	9.00
Total	\$22.50

The Water shall become the property, of the person paying therefor, and shall be placed on his property at his own expence:-

Section,-2. The City shall at the request of any person, as soon as practicable, make connections and furnish fixtures and meter, as mentioned in Section, One, hereof, and the person so requesting such connections to be made shall pay to the City Treasurer, the amounts mentioned in said Section, One:-

Section,-3. All water shall be furnished to ptrons, through Meters, for which charges shall be made as follows:-

A Minimum, charge of Fifty Cents,per month, shall be made for each Meter, and Two Thousand,(2000.) gallons of water may be used, and for each Additionel, One Thousand,(1000) gallons of water ,or part thereof, a charge, of Fifteen Cents, shall be made, and no person shall allow any of such water to be used, on any premises save his own, and any person haveing the water right, allowing water to be used on property not covered by said right, shall be liable for the water rate such other person or persons, would be liable for had they the water right, and the water may be turned off:-

Section,-4. No water right shall be taken out for less than Twelve Months, and all water rates, shall be due and payable on the First of each month.

Section,-5. The use of water through leaky or defective pipes, or fixtures is prohibited, Water running to waste, or to keep pipes from freezing is prohibited;-

Section,-6. No person or persons except the employers of said City shall turn on water to any premises, and when water is turned off ,for violation of any rule of the City, the same shall not be turned on until all rental and arrearages be paid and One Dollar,(\$1.00) charge for turning off and On water:-

Section,-7. The reserves the right at any time , with-out Notice, to shut Off water in the Mains for the purpose of making repairs, or extensions.

Section,-8. The City reserves the right in all cases of Non-payment of water rent within Ten days after the same becomes due, to turn off the water surply and not turn the same on again, except upon the payment of the amount due, together with One Dollar,for expence of turning off and turning on water.

Section,-9. When water is used for tempoary time and for purpose in which a Meter is not installed the rate shall be as follows:-

For a Barrel of Fifty Gallons,-:Per, barrel, Five,Cents, \$(.05)

Section,-10. When any Manafactory or shop, of any kind, or business of any kind shall use more than Twenty-Five Thousand, gallons of water in any month or months, such Manafactory, Shop or business shall be furnished water at Twelve, and $\frac{1}{2}$ Cents, ($12\frac{1}{2}$) pre thousand gallons, during the months in which over said Twenty-five Thousand gallons of water shall be used and in other months the rate as mentioned in Section "Three,(3) hereof shall be charged:-

Section,-11. The City of Hopkins shall pay for water for fire fighting purposes as follows:-

No Charge shall be made.:-

Section,-12. If the Meter gets out of order or fails to register the consumer will be charged at the average rate as shown by the Meter when in order for the preveous three months, but no reduction shall be made on account of leaks:-

Section,-13. All Meters set, and underground work including, Stop and waste shall be approved by the water works department:-

Section,-14. Any person violating any of the City's rules and regulations, govering the interduction, supply and consumption, of water, or who shall tamper with or turn on any fire hydrant, or who shall with-out the authorty of the owner of any hydrant, leave such hydrant running, or who shall with-out authority interfere with the Engine or Pump of the water works, or who with-out authority, climb upon the supports or tank of the water works shall be guilty of a misdemeanor, and fined in a sum not less than Five Dollars, nor more than One Hundred Dollars.:-

This Ordinance shall be in force and effect, from and after its, passage and approval.
