

ORDINANCE, NO. (85)

A Bill for an Ordinance making a special assessment, of Special Tax on the property adjoining and fronting on or bordering on the streets Oiled, in Oiling District, No.-TWO.-and levying said special tax against the property liable therefor,-:

Be it ordained by the Board of Aldermen of the City of Hopkins as follows,-:

Section. 1. Whereas by Ordinance of the City of Hopkins,-NO. (81) Oiling District,-N-TWO.- was formed, and Whereas by Resolution of the City of Hopkins, Passed by the Board of Aldermen of said City, and Aproved by the Mayor of said city, NO.-4. and whereas in pursuance of said ordinance and Resolution the said Board of Aldermen caused certain streets in said Oiling District to be oiled, and whereas the said Board of Aldermen by its Ordinance,-NO. (83) has approved the oiling of such streets and the costs thereof, That the following named streets in said District,-NO.-TWO. were so oiled and the costs thereof approved, to,-wit.

Morehouse Street from the East side of Third Street, to the West side of Seconed Street, Seconed Street from South side of Morehouse Street to the South side of Careoline Street, from west side of Seconed Street to First Street.

The total number of lineal feet of said Streets so oiled is Thirteen Hundred and Twelve, feet, and the total costs of oiling said Streets was, TWO HUNDRED and EIGHTY and 80/100 Dollars, and the number of lineal feet on the two-sides of said Streets so oiled is Eighteen Hundred and Seventy# Two, feet exclusive of the Crossings of such Streets, or intersections formed, by the Crossings of said streets, and the cost per-linear foot on each side of such streets would be FIFTEEN-CENTS.

Section, 2. There is therefore, hereby levied a special tax on all the property fronting or bordering on said Streets so oiled, which tax shall be a lien on said property, and which does not exceed Five cents per linear foot per month, on the property abutting on said Streets so iled, and tax bills shall be issued according to law and the Ordinances of said City against all the lots, or parcels of ground fronting or bordering on said Streets so oiled, in amount and described as follows,- to,-wit:
