Be it ordained by the Board of Aldermen of the City of Hopkins, as follows,-

Section,-1. Whereas by Ordinance of the City of Hopkins, NO-(81) Oiling District, NO,-THREE,-was formed and Whereas, by Resolution, of the City of Hopkins, passed by the Board of Aldermen, of said City, and approved by the Mayor of said City, NO,-4. and whereas in pursuance of said Ordinance and resolution, the said Board of Aldermen, caused certain Streets in said oiling District, to be oiled, and whereas the said Board of Aldermen by its Ordinance NO,-(83) has approved the oiling of such streets and the costs thereof, That the following named streets in said District,-NO.-THREE,-were so oiled and the costs, thereof approved,-to wit.

Barnard Street from the East side of Fifth Street, to the East side of Eight Street.

The total number of lineal feet of said streets so ciled is_FIVE_
HWINDRED and EIGHTY_FOUR, feet, and the total costs of ciling said streets
was -TWO HUNDRED SEVENTY_THREE, and 60/100, Dollars, and the number of
lineal feet on the two sides of said streets so ciled, is Thirteen Hundred
and Sixty_Eeght feet, exclusive of the Crossings, of such streets, or
intersections formed by the crossings of said streets, and the cost per
linear foot on each side of such streets would be, Twenty_Cents.

section, 2. There is therefore hereby levied a special tax on all the property fronting or bordering on said streets so oiled, which tax shall be a lien on said property, and which does not exceed Five_Cents per linear foot per month; on the property abbuting on said streets so oiled, an tax bills shall be issued according to law, and the ordinance of said city against all the Lots or parcels of ground fronting or bordering on said streets so oiled, in amount and described as follows— Towit:
