There was presented,-- A Bill for an Ordinance, Levying the Poll Tax in the City of Hopkins for the Year, 1920.

Be it Ordained by the Board of Aldermen of the City of Hopkins MO as follows,--:

All male persons between the age of -Twenty-One and Fifty Years, who have resided with-in the corporated limits of the City of Hopkins MO for Thirty-days prior to the passage of this act, are hereby required to work on the Streets and Alleys of said City, Two-days for the Year 1920, or in lieu thereof, to pay to the Street Commissioner, of said City the sum of Two-Dollars, and if said work is not done at the time, and place at and for which notice is given by the Street-Commissioner, said Two-Dollars, shall immediately become due and payable, and suit shall be brought for the collection thereof, according to Law, and the City Attorney, shall be allowed a fee of Five-Dollars (\$5.00) for bringing said suit which fee shall be taxed as costs against the defendent in such suit against whom judgment is rendered.

This Ordinance shall be in force and effect from and after its passage and approval.

Motion made and seconed that this Ordinance be placed upon its first reading, this motion prevailed and it was read the first time as follows,:

Be it Ordained by the Board of Alderme of the City of Hpkins MO as follows,--:

There is hereby avied for the year 1920, a tax of -Twenty-Five Cents, on the One-Hundred Dollar valuation on all property in the City of Hopkins, for ~~### ###~~ general perposes,-- and

There is hereby levied for the year 1920 a tax of -Sixty-Five Cents on the One-Hundred Dollar valuation on all property in the City of Hopkins for the purpose of paying the interest, and bonds, for building the City Waterworks,-- and

There is hereby levied for the year 1920, a tax of -Twenty-Five Cents, on the One-Hundred-Dollas, valuation, on all ~~#####~~ taxable property in the City of Hopkins for the purpose of lighting the City of Hopkins.

This Ordinance shall be in force and effect from and after its passage and approval.

On Motion made and seconed that this Ordinance be read a seconed time, -This motion prevailed, and it was read a seconed time.

Motion made and seconed that this Ordinance be read a Third time and placed upon its final passage,-- This motion prevailed and it was read a third time.

Block,(35) to construct a Cement Side-Walk, adjacent to said lots along the east-side of 5th Street, City of Hopkins MO as provided by Ordinance No.-26,--Passed and approved Sept, 1st -1909.
