At this time the current Expenses were discussed as were special permission for IRS Tax Payment, MO Lagers Payment, and United Electric Payment. The topic is tabled at this time.

City Clerk informed Aldermen the Auditor asked for all records from June 2023 and explained the time frame of the audit was to be June 2022 to June 2023. The Auditor asked for financial records from 2021 to compare procedures used in the current time period. The Auditor has received all information and material requested. The Auditor emailed the City of Hopkins the audit should be completed before the new year.

The City Clerk informed the Aldermen the Ad was placed in the paper for the open Aldermen position. The City Clerk explained there has been no interest submitted for the vacant Alderman position to date. The Aldermen discussed the current vacant position on the Board of Aldermen.

The City Clerk informed the Aldermen the Election Packet for April 2024 has been received. The positions occupied by Allan Thompson and Rick Gladman are up for vote this coming year.
